Due to demand, photography sessions will be confirmed with payment and signed contract two weeks prior to the photography session date. Photography Sessions are available in two hour increments from normal daytime Garden hours. Peak month photo sessions (March - June and September - October) are available Tuesday - Friday only. Off peak months may have daily availability for photo sessions, to include weekends. During The Garden's *Garden Lights Holiday Nights* exhibit, all guest must be off the grounds by 4 pm. No after-hours shoots will be available.

# Photography Session Rules



- All professional photography sessions must be booked through the Atlanta Botanical Garden Special Events Office two weeks in advance.
- The Photography Session fee includes admission for up to ten guest total, this includes the photographer. Additional attendees over contracted guest count will be charged \$32 per guest.
- During *Garden Lights Holiday Nights*, all guest must be off the premises by 4 p.m. After-hours shoots are not available.
- Vendors and props are not permitted, including but not limited to: music, signage, balloons, animals, pyrotechnics/sparkers, candles, bubbles, chalk, glitter, confetti, alcohol, cake or other food items.
- Client may not attach any items to or from any structure on-site, such as trees, bushes, railings, sculptures.
- Client may not climb on railings, walls, fountains, or other areas not generally associated with foot traffic. Please remain on the pathways and turf grass at all times. At no time is anyone permitted to enter the planting beds.
- No plants, art, exhibits or Atlanta Botanical Garden property items may be removed, moved or covered for any reason.
- Please be courteous of Garden guests. Client and/or guests may not monopolize a site or inhibit access to a site or exhibit by the visiting public.
- Accessibility of exhibitions, entrances, exits, doorways, pathways and high-traffic areas must not be blocked.
- No pop-up ceremonies or proposals permitted within this photography session. Please speak with our Special Events office if you are interested in holding an elopment, ceremony or a proposal at the Atlanta Botanical Garden
- All clients must be fully and appropriately clothed (i.e. no lingerie, swimsuits or inappropriate attire).
- The Garden allows one complimentary, non-weather-related rescheduling. Each additional rescheduling will result in an additional \$100 fee. Weather cancellations/rescheduling can be made no more than 48 hours in advance.
- Depending on availability, special arrangements may be made for use of a private room for wardrobe and makeup. This incurs an additional fee of \$500.
- No political, religious or fund-raising organizations are permitted to use the Garden as a photography location.
- Any unauthorized portrait/commercial photography sessions will be asked to comply with our policies or will be asked to end their session.
- The Garden reserves the right to intervene if a photographer, client and/or guest are found violating any of our policies. They may be asked to end their session if steps are not taken to comply.
